## NOTIFICATION TO ABUTTERS BOSTON CONSERVATION COMMISSION

In accordance with the Massachusetts Wetlands Protection Act, Massachusetts General Laws Chapter 131, Section 40, and the Boston Wetlands Ordinance, you are hereby notified as an abutter to a project filed with the Boston Conservation Commission.

A. Charlestown Marina LLC has filed a Request for a Certificate of Compliance with the Boston Conservation Commission seeking permission to alter an Area Subject to Protection under the Wetlands Protection Act (General Laws Chapter 131, section 40) and/or the Boston Wetlands Ordinance.

B. The address of the lot where the activity is proposed is Charlestown Marina Pier 6, 9th Street, Charlestown, MA 02129.

C. The project involves pile installation for a fixed pier expansion, installation of docks and floats for a commercial marina reconstruction with associated utilities, and landscaping improvements.

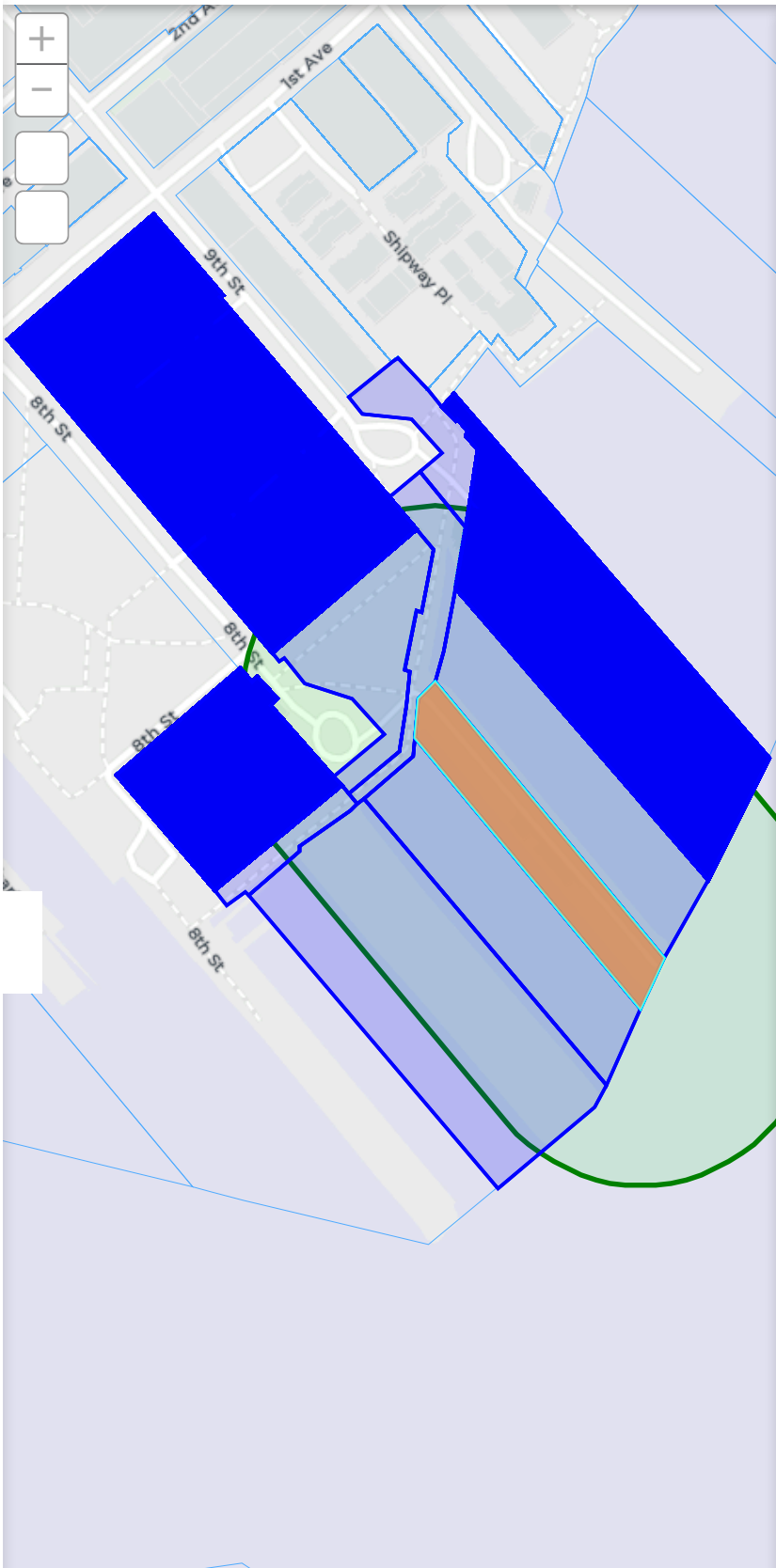
